On the First Count, the court finds the issues for the defendants and enters judgment for the defendants.

On the Second Count, the court finds the issues for the defendants and enters judgment for the defendants.

On the Third Count, the court finds the issues for the defendants and enters judgment for the defendants.

On the Fourth Count, the court finds the issues for the defendants and enters judgment for the defendants.

On the Fifth Count, the court finds the issues for the defendants and enters judgment for the defendants.

On the Sixth Count, the court finds the issues for the plaintiffs Wilhelmina and Charles Dery; James and Laura Guretsky; Susette Kelo and William Von Winkle. The defendants are permanently enjoined from demolishing the structures on properties owned or formerly owned by said plaintiffs. The statements of compensation and certificates of taking filed against said properties are dismissed. The court finds the issues for the defendants on the claims of plaintiffs Thelma Brelesky; Pasquale and Margherita Cristofaro and Pataya Construction Limited Partnership, and enters judgment for the defendants on the claims of said plaintiffs.



On the plaintiffs' motion for temporary injunctive relief, by stipulation of the parties decided contemporaneously with the complaint for permanent injunctive relief, the court grants a temporary injunction restraining the defendants from demolishing the structures on properties owned or formerly owned by the plaintiffs Thelma Brelesky; Pasquale and Margherita Cristofaro and Pataya Construction Limited Partnership pending a final resolution of this matter in the appellate courts.
